**ORDER UNDER SECTION 144 Cr.PC. (Amendments)**

In view of the guidelines/order issued by Government of India Ministry of Home Affairs vide No. 40-3/2020-DM-I (A) dated 24<sup>th</sup> March, 2020 and subsequent amendments vide even number dated 25<sup>th</sup> March 2020, and in order to ensure adequate supply of essential goods during the curfew period, I, Rugved Thakur, (IAS), District Magistrate, Mandi, (Himachal Pradesh) in exercise of the power vested in me under Section 144(5), of The Code of Criminal Procedure, 1973 do hereby order following amendments in the order issued vide no. DC/MAN/LA/2020-1636-1695 dated 24<sup>th</sup> March, 2020 :-

**Following items shall be inserted under the exemptions:-**

16. Veterinary, Hospitals, Sub-Centers, pharmacies and supply chain of fodders.
17. Shops for seeds and pesticides and its supply chain.
18. Forest staff /workers required to operate and maintain zoo, nurseries, wildlife, fire fighting in forests, watering plantations, patrolling and there necessary movement.
19. Treasuries and Insurance offices
20. Cold storage and warehousing.
21. Private security.
