**ORDER (Amendments in Curfew)**

In partial amendment of this office order Endst. No. 5114-5120/MA-MC-I dated 24-03-2020 regarding enforcement of complete curfew in territorial of jurisdiction of Una District the relaxation is made in the following manner:-

- (i) The shops or stores selling Groceries, Milk , Bread , Fruits , Vegetable, Meat , Fish and other uncooked food items, fodder shops/stores, pesticides/insecticide stores, liquor vends **will remain closed except form 7:00 AM to 10:00 AM w.e.f. 26-03-2020 & between 4:00 PM to 7:00 PM on 25-03-2020.**
- (ii) All the sabji mandies of District Una i.e. Una, Santoshgarh & Takarala **will remain closed except 5:00 AM to 8:00 AM for traders and 7:00 PM to 9:00PM for farmers.**
- (iii) The purchasing of essential items can be done from 7:00 AM to 10:00 AM. One fit person from a family will come out from home for procurement/purchase. Elderly and vulnerable persons will remain inside the home. Essential items delivery to the vulnerable people will be taken care by the Executive Officer, Municipal Council Una, Santoshgarh & Mehatpur Basdehra & Secretary Nagar Panchayat Gagret/Tahliwal & Daultpur Chowk for availing these facilities such persons will have to get registered with the Municipal Council Una, Santoshgarh & Mehatpur Basdehra & Secretary Nagar Panchayat Gagret, Tahliwal & Daultpur Chowk (Vulnerable person defined as person who is senior citizen living alone or living as couple with no son/daughter to take care).
- (iv) However, under no circumstances there shall be an assembly of five or more persons anywhere out of their houses/ shops. Further, any movement of general public during the above mentioned period will be strictly restricted from home to essential services establishment/marketplace and back.
- (v) Any shop/store allowed for above periods shall not sell any other items as stated at (i) or (ii)
- (vi) All shops commercial establishments, workshops, godowns except as stated at point (i) & (ii) above **will remain closed.**
- (vii) Above restriction **will not apply** on Hospitals, Chemist Stores, Optical Stores, Pharmaceutical stores, Petrol pumps, LPG gas, Oil agencies, their godowns.
- (viii) There shall be total prohibition on the movement of public and private stage and contract carriage including taxis, autorickshaws etc.




- (ix) There shall be total prohibition on the movement of private vehicles including **two wheelers** for any purpose except for ferrying patients or hospitals or persons commuting to offices for the maintenance of essential services and law and order or specially permitted by undersigned.
- (x) Goods transport vehicles transporting essential commodities or being used for maintenance of essential services.
- (xi) No person other than specially exempted by state or engaged in essential services shall come out of home except for buying essential commodities/ services in the permissible time intervals or visiting hospital with patient/buying medicines.
- (xii) This prohibition will not apply on offices declared as essential by the Govt. of HP vide order No. HFW-A-A(3)1/2020 dated 23<sup>rd</sup> March, 2020 and their staff is being deployed for rendering uninterrupted services throughout the state on 24X7 Basis.
- Offices charged with law and order and magisterial duties.
  - Police, Armed Forces and Central Para-Military Forces
  - Health
  - Treasury
  - Urban Local Bodies and Rural Development
  - Fire
  - Electricity, Water and Municipal Services
  - Bank/ATM
  - Print, Electronic Media
  - Telecom & Internet Services including it & items/ Pvt. Telecom Services
  - Postal Services
  - Supply Chain and Related Transportation including railway
- (xiii) Private Security Personnel in uniform while on/commuting for duty.

All Head of Offices would issue Photo ID Card to such employees for facilitation of their movement.

This order be read in continuation with the order dated 23-03-2020 issued by Additional Chief Secretary (Health) Government of Himachal Pradesh.

This order shall come in force with immediate effect till further orders. Issued under my hand and seal at 04:00 PM on 25-03-2020.


