**ORDER**

**Whereas**, 'lockdown/ curfew' has been imposed in various parts of the State in order to contain spread of the COVID-19 pandemic. It has been observed that despite several social welfare measures undertaken by the State Government during these forced restrictions, hardships might still be faced by the citizens, particularly the poor and marginalized sections of the society. It is also felt that concerted and co-ordinated efforts on part of the State Government, civil society and all citizens are required to bolster the healthcare infrastructure in the State in this hour of need.

**Whereas**, Sh.
