ORDER

Whereas, the Department of Tourism & Civil Aviation, Himachal Pradesh vide letter No.5-99/2020/TSM-201 dated 9th June, 2020, has issued COVID-19 Safety and Hygiene guidelines for Tourism Sector in accordance with the guidelines issued by the Ministry of Tourism, Government of India for operation of Hotels and other accommodation units in the State.

Whereas, Department of Tourism & Civil Aviation, HP has issued additional Standard Operating Procedures (SOPs) vide order dated 4th July, 2020, 24th July, 2020, 26th August, 2020 & 3rd September, 2020.

Whereas, Chief Secretary-cum-Chairperson, SEC, Himachal Pradesh vide Order No.Rev(DMC)(C)20-2/2020-COVID 19 dated 16th September, 2020 has issued following directions:-

3. Monitoring the spread of COVID-19 and Contact Tracing:

- (i) There shall be no requirement of registration for inter-State and intra-State movement of person and goods. No separate permission/approval/e-permit will be required for such movements. However, Inter-State movement of public transport buses shall be operated only as per the SOPs to be issued by the Department of Transport, Himachal Pradesh after ensuring full readiness to comply with the SOPs.
 - (ii) All SOPs issued by different Authorities/ Departments till date shall be aligned in view of the directions at 3(i) above.


Therefore, the undersigned in partial modification of SOPs issued earlier, amend the existing guidelines as follows for information and strict

compliance thereto of all concerned :-

1	<ul style="list-style-type: none">• The minimum duration of stay required previously is now reduced to two nights spread over multiple locations.• The intending Tourist may get Trunaat /CB Naat Test (negative report in alternative to RT-PCR test, but still from a accredited/ authorized laboratory within a period of 96 hours till the State border.• The period of 96 hours in which tests indicated have to be done will be counted till the border of the State and not for any internal check points.• IT Deptt. shall modify the e-pass software to generate a separate consolidated list of applications under "Tourists" Category. The District Administration shall scrutinize the uploaded documents within a period of "24 hours" of the submission of the applications and give their opinion, else it will be deemed to be approved and the software should automatically forward/	There shall be no requirement of registration of inter-State movement of persons. No separate permission/ approval/ prior testing will be required for such movements.

2	Packed food take away counter shall be mandatory	Deleted
3	Tourists while traveling on highways be allowed to halt only at designated way side amenities and refreshment centre / areas.	Deleted
4.	Banqueting – A total of maximum fifty guests will be allowed in a family / social function	The maximum number of guests permitted in banquet halls for a family/ social or any gathering shall not exceed the number prescribed by Chairman, National Executive Committee, National Disaster Management Authority-cum-Home Secretary, Government of India from time to time.


