NOTIFICATION

In continuation of this department's notification of even number dated 17th July 2023 vide which "Special Relief Package" for providing relief and rehabilitation to the people affected by the flash floods, cloudburst and landslides in the State which was notified from 07.07.2023 to 15.07.2023, the Governor, Himachal Pradesh is pleased to expand the benefits of this package w.e.f. 24-06-2023 to 30-09-2023 and also modify the relief assistance for certain items of the table of the "Special norms for relief and rehabilitation from rain, flood and landslide damages" notified as under-

Special norms for relief and rehabilitation from rain, flood and landslide damages in monsoon 2023:

Applicability:

Damages sustained from rain, floods and landslides between 24-06-2023 to 30-09-2023.

Special Norms of Assistance

Sr. No.	Type of Damage/Loss	Amount	Process of Verification
1.	Fully damaged House (Kutcha or Pucca)	Rs. 7,00,000/-	Report of Patwari
2.	Partially damaged House (Kutcha or Pucca)	Rs. 1,00,000	Report of Patwari
3.	Damage to Shops and Dhabas	Rs. 1,00,000	Report of Patwari
4.	Loss of belonging of tenants	Rs. 50,000	Report of Patwari. May take report of Panchayat Secretary of Gram Panchayat.
5.	De-silting of agricultural and horticulture land	Rs. 5,000 per bigha	Report of Patwari
6.	Land loss of agriculture and horticulture land	Rs. 10,000 per bigha	Report of Patwari
7.	Crop damage	Rs. 2,000 per bigha	Report of Patwari
8.	Loss of large milch and draught animal*	Rs. 55,000	Report of Patwari. Reports of Panchayat Secretary of Gram Panchayat and Animal Husbandry Department may also be taken.
9.	Loss of goat, pig, sheep and lamb*	Rs.6,000	Report of Patwari. Reports of Panchayat Secretary of Gram Panchayat and Animal Husbandry Department may also be taken.

* Ceiling of number of cattle will not be applicable.

Process of sanctioning:

The Patwari shall prepare Naksha Quaif (as per format given in HP Land Records Manual, 1993) of every damage and submit it to Field Kanungo, who will verify each damage case by visiting the site of damage.

The Field Kanungo will submit it to the Tehsildar/Naib Tehsildar for further necessary action. Final sanction shall be given by SDO (C) upon receipt of recommendation from Tehsildar/Naib Tehsildar.

Funding Mechanism:

Amount of assistance as admissible under the norms of **assistance notified by the Ministry of Home Affairs, GOI on 11-07-2023** shall be paid from SDRF/NDRF. Additional amount shall be paid from additional funds to be provided by the Govt. of HP for this purpose. Separate accounts of the assistance provided shall be kept by the authorities.

The relief and rehabilitation activities will be carried out as per the above norms by the Sub-Divisional Magistrate concerned strictly following the process of sanctioning as mentioned above.





Standard Operating Procedure for providing Relief to the beneficiaries under “Special Relief Package” for the period 24-06-2023 to 30-09-2023.

1. The enhanced amount Rs 7.00 lakh of relief under this ‘Special Relief Package’ is only applicable in case of the fully damaged Pucca Houses/Kutchas Houses.
2. The amount of relief for the fully damaged/partially damaged pucca houses shall be paid in instalments. Whereas 100% relief assistance shall be paid to victims for the other items notified under Special Relief Package.
3. The amount over and above the SDRF/NDRF norms notified by the MHA on 11th July 2023 shall be paid from the budget to be provided by State Govt.
4. The amount of Rs 1,30,000/- admissible under SDRF/NDRF norms for fully damaged houses shall be paid immediately to the affected families.
5. The amount of Rs 1,50,000/- sanctioned by the Rural Development Department under Pradhan Mantri Awas Yojana (PMAY) shall also be adjusted while sanctioning Rs 7,00,000/- for the fully damaged Pucca/Kutchas House, wherever applicable.
6. In the cases where the amount of Rs. 1,30,000/- has been paid from the SDRF/NDRF, and Rs 1,50,000/- has been paid under PMAY (Pradhan Mantri Awas Yojana) the balance amount of Rs 4,20,000/- shall be paid in the following manner:-

7. In the cases where the amount of Rs. 1,30,000/- has been paid from the SDRF/NDRF, the balance amount of Rs 5,70,000/- shall be paid in the following manner:-

8. The Deputy Commissioners will make effort to include all beneficiaries whose houses have been fully damaged under PMAY.
9. The house owner shall construct house with earthquake resistant features and provide seismic bands at plinth, sill and lintel level. Vertical reinforcement along with single steel bar at every junction shall also be ensured.
10. The plinth of the house should be up to the hard rock/consolidated soil.

Further, the amount under Item "Crop Damages" at Sr. No. 7, as notified on 13-10-2023, may be read as Rs 4000/ in place of Rs 2000/-.

All other terms and conditions, mentioned in the notification dated 13-10-2023 shall remain the same for sanctioning the funds from the Special Relief Package.
