**NOTIFICATION**

In continuation of this department's notification of even number dated 14-08-2025, the Governor, Himachal Pradesh is pleased to notify that Special Relief Package, notified for disaster affected areas of Mandi District, is hereby extended to disaster affected areas of all the districts of Himachal Pradesh for the damage/losses caused during monsoon disaster 2025 (from 20-06-2025 to 26-09-2025). Such disaster affected areas will be notified separately by concerned Deputy Commissioners for this purpose.

The Governor, Himachal Pradesh, is further pleased to notify the following amendments in Sr No. 6 and Sr No. 7 of the Standard Operating Procedure of the Special Relief Package, notified on 14-08-2025:

**Sr No. 6 of the SOP will now be read as under:-**

In the cases where the amount of Rs. 1,30,000/- has been paid from the SDRF/NDRF, and Rs 1,50,000/- has been paid under PMAY (Pradhan Mantri Awas Yojana) the balance amount of Rs 4,20,000/- shall be paid in the following manner: -


