Regarding – Revised Consolidated Guidelines issued by the National Executive Committee, Ministry of Home Affairs, Government of India for the State Governments for containment of COVID-19 dated 14th and 19th April 2020.


Sir/Madam,

I am directed to refer to the DO letter No. 40-3/2020-DM-I(A) dated 19th April, 2020 received from Home Secretary, Ministry of Home Affairs addressed to the Chief Secretaries of States (copy enclosed) vide which he has informed that vide order of even number dated 19th April, 2020 **clause 14 (v) of the consolidated revised guidelines, relating to E-commerce companies has been excluded.**

In this regard it is clarified that while operations of e-commerce companies for non-essential goods stands prohibited, however they will continue to operate for essential goods as has been allowed earlier and continue to be allowed under clause 13 (i) of these guidelines.

You are, therefore, requested to kindly adhere to these guidelines and orders issued from time to time in letter and spirit and adequately disseminate the same amongst the field level functionaries and general public so as to ensure smooth movement of the entire supply chain of essential goods including by e-commerce. Violations of the directions of NDMA, NEC and SEC may be dealt as per the provision of the DM Act, 2005.

Dear *Chief Secretary,*

Please refer to MHA Order No. 40-3/2020-DM-I(A) dated 15th April 2020 & 16th April 2020, vide which consolidated revised guidelines on the measures to be taken by the Ministries/ Departments of the Government of India, State/UT Governments and State/UT Authorities for containment of COVID-19, has been circulated for the strict implementation in all parts of the Country.

2. Vide Order of even number dated 19th April, 2020, ***clause 14(v) of the consolidated revised guidelines, relating to E-commerce companies has been excluded.*** In this regard I would like to clarify that while operations of e-commerce companies for non-essential goods stands prohibited, ***however they will continue to operate for essential goods as has been allowed earlier and continue to be allowed under clause 13(i) of these guidelines.***

3. You are therefore requested to clarify this to all the field agencies and also adequately disseminate amongst the general public so as to ensure smooth movement of the entire supply chain of essential goods, including by e-commerce. The guidelines/ Orders issued by the State Governments/ UT Administration in pursuance to MHA Orders may please be suitably modified to reflect the correct position.
