Sub- Regarding—CWPIIL No. 11 of 2020 a/wCWP No. 2687 of 2020 in the Hon'ble High Court and reiteration of the Order dated 28.11.2020 issued by the State Executive Committee for containment of COVID-19.

Sir/Madam,

In compliance of the Hon'ble High Court of Himachal Pradesh Order in CWPIIL No. 11 of 2020 a/w CWP No. 2687 of 2020 decided on dated 03.12.2020, the relevant directions already issued by the State Executive Committee vide its Order No. Rev (DMC)(C)20-2/2020-COVID19 dated 28.11.2020 (copy enclosed at Annexure 1) are hereby reiterated with specific reference to the Hon'ble High Court's Order (copies enclosed as Annexure 2 & 3) with following instructions:

- a) Since the permission for gathering etc. are being given through the web portal developed by IT department, the details of such permissions granted should be also shared with Panchayati Raj Institutions (PRIs) and Urban Local Bodies (ULBs) apart from the officer incharges of police stations in the State. All the office bearers of the PRIs/ULBs as the case may be, are to ensure that the protocols and procedures including wearing of mask, social distancing, home isolation, public gathering etc. issued by the government are strictly adhered to. They will visit and coordinate with the event organizers prior to the event that only the permitted number of the persons should attend the event, followed by strict compliance of COVID-19 directives during the event. Any violations of the directives in this regard shall be brought to the notice of the District Administration forthwith.
- b) Each SDO(C)/SDM may divide their respective area into sectors and distribute the responsibility to various officers for effective monitoring and implementation of the norms and safety measures required in the gatherings. They shall ensure strict compliance and take needed action in this regard.

- c) The Deputy Commissioners shall make all efforts to highlight toll free No. 1077 of the District Emergency Operations Centre (DEOC) for any assistance/complaint to ensure that no person or family is ostracised/excluded by the Society only because the family is COVID positive. The information about these helplines may be disseminated widely in the field.
- d) Department of Health & Family Welfare in association with Department of Information Technology would develop a mobile/web app to key in the information of the home isolated persons/patients to ensure the protocols for home isolation are being followed properly. The information of the persons/patients in home isolation to be mapped with the Doctors/Paramedics through this application and the data reports are to be shared with the respective District Emergency Operation Centers (DEOC) and Chief Medical Officer for further necessary action. Till the application is prepared by Health/IT Department, concerned CMO will share the data of Home Isolated patients in excel sheets on daily basis with the DEOC.
- e) The staff posted in the DEOC is also directed to contact the home isolated COVID-19 patients by making calls daily (if no. of patients is large, on alternative days) and enquire about:
 - i. Whether the patient(s) have been supplied with medical kit & Oximeter, etc?
 - ii. Whether mapped Doctor/Medical Officer/Para Medical Staff is talking to them twice a day and monitoring their health indicators?
 - iii. The general condition i.e. temperature, SPO2 (Oxygen level) etc of the patient and in case of deterioration of his/her condition, get in touch with the medical authorities for shifting of patient.
 - iv. If any gap is found in monitoring of patients by mapped Doctor/Medical Officer/Para Medical Staff , the same shall be reported to CMO on daily basis.

You are, therefore, requested to kindly adhere to the guidelines issued vide SEC order dated 28.11.2020 with specific reference to above mentioned directions in this letter and spirit, and violations of the directions may be dealt strictly as per the provision of the Disaster Management Act 2005/HP Police Act.
