
Provision of revolving fund to Tehsildars and SDMs under Relief.



OFFICE ORDER

In exercise of the powers vested in me under Rule 2.24 & 2.32 of H.P. Financial Rules, 2009, and in continuation to this Department officer order No. Commr.(Rev) HP-C(1)-15/2000 dated 2nd June, 2001 I hereby declare all the SDMs (C) in District in HP as a Head of Office and DDO under Budget Head 2245 (S00N/ C00N) and its all Minors/ Sub Minors Budget Heads. In addition to this a provision of imprest money under budget head 2245-02-101-01-S00N-NP (OC) (Immediate relief) has been made to meet unforeseen expenditure as under:-

1. Deputy Commissioner level = Rs. 10.00 lakh (Rupees Ten Lakh) only.
2. SDMs level = Rs. 05.00 lakh (Rupees Five Lakh) only.

Above imprest amount is subject to adjustment as per the provision of HPFR 2009 and shall be utilized during the respective financial year only.


