- Oversee installation and operationalization of Early Warning Systems (EWS) and monitoring networks.
- Facilitate engagement of domain experts, research institutions, or additional specialized agencies when needed.
- Ensure adherence to programme guidelines issued by NDMA/NCS/GoI.
- Address implementation challenges and recommend corrective actions.
- Review and endorse reports, documents, and submissions to be forwarded to NDMA/MHA.
